Our Mission

Increasing numbers of people in Scott and Carver Counties are finding themselves without adequate insurance. People who are uninsured often have difficulty locating and accessing existing health care and social services and are often unaware that there are free and low-cost services available to meet their needs.

Within the Mission of the River Valley Nursing Center, lies the core of our working philosophy: "promoting the leadership role of nurses." RVNC helps people connect with existing services while offering high quality nursing assessments and health education.

Our Philosophy

- Experienced Public Health Nurses provide a complete individual and family assessment which includes financial, safety, shelter, health and dental care, and emotional and mental health status.
- · Care is then provided at the Nursing Center as appropriate with appointments and/or referrals made as necessary.
- Community Health Workers/Spanish translators provide the necessary language assistance to insure that information is obtained and provided competently to all clients and their families.
- · Services provided include: blood pressure and glucose screening, pregnancy testing, medical follow-up, medication review, health education and free flu vaccines.

Did you know?

- RVNC has had nearly 1,400 client visits to date
- 100% of our clients are uninsured
- 40% of our clients are repeat visitors
- More than 50% of our clients are minorities
- Nearly 1,500 referrals have been given to social service agencies and medical clinics

From the Board Chair



The River Valley Nursing Center is entering its fifth vear of service in our community and I am proud to say I've been a part of this project for that entire time. When a small group began to meet in 2003 we didn't know that we were going to create

a nursing service delivery model for people lacking insurance. We only knew that we were committed to doing something about this challenge facing so many people in our community. We have passed many milestones since that time:

- Created a pioneering care delivery model that emphasizes the leadership role of nurses.
- Received major funding from the Park Nicollet Foundation, St. Francis Regional Medical Center, the United Way, St. Francis Foundation, and the St. Paul Foundation as well as wonderful gifts from Rotary Clubs of Shakopee and Prior Lake, and St. Victoria Church.
- Achieved over 30% return visit rate from clients demonstrating the trust level they have in our services and integrity.
- Built trust in our community, especially with the Latino community who make up 49% of our clients.
- Hired an Executive Director to help us take this model to the next level and replicate it in other communities.
- Expanded hours of operation at our Shakopee site.
- Added a second location in Chaska.

Since the Nursing Center opened in April 2005 the number of people without insurance in our community has risen steadily. We are grateful to do our part to help and are proud to be making a difference in our community in such a meaningful way. Our clients continue to tell us about the impact we are making in their lives to improve their health. These efforts strengthen the health of our entire community.

We look forward to achieving our next milestones. Thank you for your support of the River Valley Nursing Center.

Client Story #1

Joe, a 16-year old male came to the Nursing Center seeking assistance controlling his diabetes until he could be reinstated into the Medicaid program. His blood glucose was 259 mg/dl and only had five days worth of medication remaining. His mother feared the consequences, "Without help, he will be in the Emergency Room this weekend."

River Valley Nursing Center was able to assist the client in securing an appointment at St. Mary's Health Clinic and ensuring he had enough medication through International Diabetes Center. The nursing center also contacted the Medicaid case worker to follow up on his application.



The intervention RVNC provided met the family's needs and an expensive emergency room trip was avoided.

Client Story #2

Maria had been seen at the Nursing Center for various health needs. On one visit, she brought a large medical bill she'd received for emergency services. She had been contacted by a collection agency and was concerned that she did not have the money to pay for it by the due date.

Nursing Center staff contacted the collection attorney, explained the bill, and helped her set up a payment plan. The language barrier impaired her ability to solve a problem and our translator helped her in a caring and understanding manner.

Persistence in helping clients work to solve their problems is one of the strengths of the River Valley Nursing Center staff.


