### A YEAR OF GROWTH AND IMPACT

As we reflect on the strides made by River Valley Health Services (RVHS) in 2023, it is with a sense of pride and anticipation that I share our journey of the

past year. Our services have expanded, and the client numbers for 2023 were strong. Our most significant milestone was establishing a new home for our Shakopee Clinic in collaboration with the CAP Agency. RVHS will reopen its clinic

in Scott County after being without space for over two years. The CAP Agency refurbished the space, transforming it into a welcoming facility. Our goal is to open doors in 2024, and we are actively working towards equipping and staffing the clinic to provide our services, starting one day a week, every Tuesday.

One of the fantastic things about our small, non-profit, free healthcare clinic is that we can spend enough time with a patient to accomplish life-changing outcomes. On the cover of last year's 2022 Annual Report is a patient named Betty and her lovely dog, Lucky. With Betty's permission, I am pleased to share that she is thriving along with Lucky and is now a patient representative member of our Board of Directors.

Our achievements in program development have been notable. We started the year with the Minnesota Department of Health Arthritis Program "Walk with Ease." The six-week innovative program reached many individuals who have chronic arthritis, including Spanish speaking patients, for the first time. Together, we learned to take advantage of proven arthritis self-management through a structured program conducted at the Shakopee and Chaska recreation centers. The RVHS staff had to become certified instructors to lead the participants.

Recognition of our efforts came with the American Heart Association's Business Accelerator, EmPOWERED to Serve event in June, highlighting the groundbreaking work of our free clinics. The Minnesota Lions Diabetes Foundation's "Catch the Dream" Award was another feather in our cap, honoring our innovative approach to diabetes care and prevention. One of the core competencies of River

Valley has been our work in diabetes screening and care, especially for high-risk groups such as Hispanics, veterans and those with limited resources.

Complimenting these efforts, we began working with the Veggie Rx program at the University of MN Arboretum, which provides free vegetables via prescription to our high-risk, patients suffering from diabetes.

Financially, we closed the year with a solid

fund balance, ensuring our ability to continue providing quality services and outreach. We provided services to nine hundred patients, conducted outreach to four hundred attendees and did this with a team of volunteer health care providers, volunteers, and part-time employees.

Looking ahead, our Shakopee Clinic will be a nucleus for diabetes care and community outreach in Scott County. We are also exploring the addition of varied medical services to meet the diverse needs of our patients. The CAP/RVHS model we presented at the American Heart Association competition is a blueprint for our innovative infrastructure development and has reinforced our grant applications to the Minnesota Department of Public Health and others.

As we forge ahead, we are conscious of the funding challenges that still need to be solved. We stand on the precipice of an exciting new chapter, ready to broaden the scope of our impact on the community we serve. Our donors are unique, delivering prayers, equipment, funds, and service.

We are here to help those with nowhere else to turn. ~Bill



# RVHS CLIENT STATISTICS



### 2023 CLIENT STORIES



A middle-aged man was referred to RVHS for medical evaluation after his Department of Transportation (DOT) physical indicated possible diabetes, which was jeopardizing his employment with a trucking firm. Without medical insurance and facing unemployment, the patient was in urgent need of healthcare support.

RVHS confirmed his diabetes diagnosis, with an initial A1C level over 14. We initiated treatment with Metformin and provided comprehensive education on diet and self-care, including glucose monitoring at home. Our intervention enabled him to meet the DOT medical standards, thus securing his job and financial stability.

Over the subsequent months, the patient demonstrated remarkable compliance with his treatment plan, significantly decreasing his A1C to 7. This improvement not only safeguarded his health but also his family's financial security.

During his follow-up appointment, the patient expressed profound gratitude and was visibly moved, attributing the maintenance of his livelihood and family safety to the care provided by RVHS. Despite having regained insurance, he opts to continue his follow-up care at our clinic, a testament to the trust and relationship built with our team.

A parent to a son under RVHS care, faced multiple family challenges. Residing with her sisters, brother, and their father—who had a history of incarceration and potential immigration issues—the family was experiencing financial hardship. The seasonal decrease in employment opportunities further exacerbated their situation, leading to food insecurity. RVHS responded by supplying essential groceries to sustain the family until Carver County's additional aid became available.

A pregnant adolescent girl presented to RVHS with concerns about decreased fetal movement. Dr. Willey attended to her. Despite being new to the country and language barriers, the girl expressed reluctance to seek emergency care due to the absence of insurance and associated costs. Compounded by her mother's inability to leave work for fear of job loss, they planned a hospital visit for the upcoming weekend when her mother was off work. Dr. Willey confirmed fetal well-being but noted a scheduled induction without the girl's understanding of why. Dr. Willey and Nurse Heidi collaborated with Allina to clarify the induction rationale and reassured the girl about emergency care, irrespective of insurance status. Subsequently, the student delivered a healthy baby days later.

RVHS recently assisted a newly settled patient in the country with a financial dilemma stemming from a lack of health insurance. After incurring a few thousand dollars in charges from an emergency room visit for abdominal pain, the patient sought our help to navigate the complexities of medical billing and insurance application. Our team facilitated the initiation of a payment plan and connected the patient with Portico, a non-profit that aids in securing medical insurance. We managed to defer the payment obligations while the patient's application for medical emergency assistance was being processed. Within two weeks, the patient returned to RVHS, this time with insurance coverage for the prior ER visit. Additionally, we provided education on the appropriate use of urgent versus emergency care. The patient is now enrolled with RVHS for ongoing healthcare services.

A recent immigrant and mother, presented at RVHS with intercostal pain, just ten days after her arrival. The RVHS team noted her lack of appropriate attire for Minnesota's severe winter, as she only wore sandals and a sweatshirt. Beyond medical care, which included a prescription for her pain, one of our providers personally offered her boots as a gift to the patient in an act reflecting RVHS's commitment to patient well-being. Further support was provided through a referral to the CAP agency, which furnished the patient and her children with essential winter clothing.

A young woman presented at our clinic exhibiting fully dilated pupils, dark circles under her eyes, and a demeanor suggestive of psychological withdrawal. Her inability to maintain eye contact and reliance on a family member to communicate indicated severe distress. Further evaluation revealed that the patient had endured a traumatic ordeal, having been held against her will at the border for an extended period.

Her family, upon her arrival in the U.S., observed alarming behavioral changes, including compulsive hygiene and self-deprecating remarks

coupled with tearfulness. Additionally, she was experiencing auditory hallucinations and delusions. Recognizing the gravity of her mental state, our team acted promptly to address this psychiatric emergency.

Collaboration with a nearby hospital facilitated her access to specialized care, resulting in a formal assessment and the initiation of appropriate pharmacotherapy. A subsequent follow-up at our clinic confirmed a marked improvement in her condition. This case underscores the critical role of healthcare providers in recognizing and acting on social determinants of health, particularly in serving vulnerable populations. River Valley Health Care's intervention exemplifies our commitment to bridging healthcare disparities for immigrants.

(M), who was diagnosed with cancer last year, has been undergoing chemotherapy at a Cancer Center. Her part-time employment status, a consequence of her medical condition, has led to financial constraints impacting her ability to afford groceries and medications, including those required for diabetes management.

On several occasions, M has sought assistance from RVHS. We have provided support through Veggie Rx, supplying vegetables, and financial aid for food. Recently, she contacted us for help with medication costs post-chemotherapy. A misunderstanding arose when M sent a form instead of the actual prescription, and it was discovered that she had not been able to purchase all the necessary medications due to financial limitations.

RVHS nurses diligently coordinated with the Cancer Center and local pharmacies to rectify the confusion regarding her prescriptions. Ultimately, we ensured that M fully understood her medication regimen, enhancing the effectiveness of her chemotherapy.

M has expressed profound gratitude for the accessible support RVHS provides, which has been instrumental in navigating her healthcare journey.

Recently moved from out-of-state, (R) came to RVHS in need of refills for her depression and anxiety medications. Without insurance and not qualifying for state insurance, she faced significant challenges in obtaining her medications. Dr. Willey prescribed the necessary medications, with costs covered by RVHS. R also scheduled a follow-up appointment for a full physical and a complimentary eye exam. She left RVHS feeling extremely grateful for the care and services provided at no cost to her.

A patient from a different country who had not sought medical attention in the United States for a year visited River Valley Health Services with a complex assortment of medications, some unfamiliar to our team. Providers Maria (PA), Heidi (nurse), Adriana (interpreter), and Isabelle (clinic assistant) dedicated two hours to meticulously reviewing his medication list. Their efforts ensured he received the necessary prescriptions for managing his blood pressure, diabetes and heart disease.

The significance of this encounter lies in the patient's delayed healthcare engagement due to his uninsured status. RVHS's intervention was pivotal, supplying needed medication and averting the possibility of serious complications from untreated heart disease.

A patient scheduled for an appointment at RVHS was redirected to Urgent Care for an X-ray by the provider, who identified the need for immediate assessment. Following the urgent care visit, where she received a nebulizer treatment,

the care provider sent a prescription for an inhaler to a nearby pharmacy. Unfortunately, the pharmacy was closed before the patient could retrieve her medication.

RVHS staff intervened, contacting the urgent care provider to transfer the prescription to a different pharmacy with extended hours. Despite a lengthy hold time with the pharmacy, RVHS advocated for the urgency of the patient's situation, stressing the need for the inhaler due to her shortness of breath.

A follow-up call a week later confirmed the patient was recuperating, albeit feeling fatigued, highlighting RVHS's commitment to patient care continuity.

A middle-aged woman reached out to River Valley Health Services, suffering from severe headache, fever, dry cough, and body aches. Our staff evaluated her symptoms and organized the direct delivery of the required antibiotics and medication to her home. We also scheduled a follow-up appointment to monitor her recovery and confirm the resolution of her symptoms.




# COMMITMENT | RECOGNITION

We received a grant enabling us to offer the Walk with Ease program and continued our commitment to free diabetes and health screening services.

We started 2023 with the Minnesota Department of Health's arthritis self-management program, Walk with Ease. We conducted the program in English and Spanish. The six-week program reached many individuals who have chronic arthritis. The RVHS staff became certified instructors and led the participants at the Shakopee and Chaska recreation centers.

We worked with volunteers, police departments, churches, community organizers, senior centers, and veterans, bringing our diabetes and health screening services to diverse populations by attending county fairs, church and community center gatherings, and community outreach events. We make testing easy and actionable, including having a nurse write a script with results and a referral.

Heidi from RVHS was like an angel; she and Bill really helped me out, finding me a place to live and sorting out my health. I'm a survivor; I live life, life doesn't live me. The people at RVHS were like a warm blanket in the cold. They're the real deal, not just going through the motions. I remember one freezing night, Dr. Willey and Heidi stayed late with me until a tow truck came. That's genuine kindness.

RVHS asked me to join their board, and I said yes to give back and share my insights. I want to help make things better here. I met some council members and Congress folks recently and talked about homelessness. They seemed surprised it is in our community. I told them, homelessness has many faces, it doesn't just look one way.

Bill and Heidi helped me fight for my health insurance, which took six months to get approved. There's a lot that needs fixing. Not everyone can zip off to Minneapolis for help. I'm here to find ways to help our people, locals and immigrants alike." ~Betty Allen
